- b. Institutions, Technical, Medical, Industrial and otherwise including Schools, Colleges, Polytechnics and research associations and institutions, vocational Training centres and workshops etc.,
- c. To aid, establish, maintain and run, hostels for the benefits of students and housing and other accommodation for teachers and others staff.
- d. To establish, maintain, run develop, improve, extend, grant, donations for and to aid and assist in the establishment, maintenance, running, development and extension of libraries, reading room and other facilities as are calculated to be of use in imparting education to the public.
- e. To establish, maintain, run, develop, improve, extend, grant, donations hostels for and to aid in the establishment of laboratories, libraries and all the other building, infrastructures as may be required for fulfilling the main objectives of running educational institutions.
- f. To give Scholarship, stipends, loans, awards, prizes and other monetary assistance for the purpose of study, research and apprenticeship to students and scholars.
- g. To publish papers hold meetings, seminars and conferences and engage in other activities as may be required to fulfilling the main objectives.

4. The Trustees may from time to time open in the name of trust one or more bank account with such scheduled bank or banks as they shall from time to time decide any two of the Trustees to whom the Secretary shall be one shall have the power to operate upon such account or accounts to draw, endorse cheque, and dividend warrants and to pay or cause to be paid to or withdraw from such account or accounts any monies forming part of the Trust property or to close accounts and open others.

5. The trustees shall have full power to file suits, make applications or take out any proceedings in respect of the trust property for the preservations or in the interest thereof to defend or reply to or appear in any suit applications or proceedings filed made or taken against them or to compromise refer to arbitrations such suit, application or proceedings in any claim or account what so ever or any matter in which the interest of the trust property and its funds may be concerned or where in the trustees as such may be parties and the trustees shall be reimbursed for all costs and expenses incurred by them in connection herewith.

6. The Trustees may deposit any deeds; securities or instruments held by them as such trustees with any bankers for safe custody and may pay out of the income of the trust property any sums payable for such custody.

7. On the admission/co-option of any person as trustee he/her shall become a member of the board to trustees and shall be entitled to participate in the deliberation of the board of trustees and the activities of the trust. The ownership of all the properties acquired by the trust shall be vested absolutely with the trustees jointly. On the admission of the additional trustee or trustees



8. all the properties moveable and immoveable, shall vest in such additional trustee or trustees along with the existing trustee or trustees.
9. There shall be a president, a vice president and a secretary for the board of trustees. All office bearers of trust shall be chosen from among the trustees. The trustees may make separate rules and regulations for election/appointment of such office because and their duties and responsibilities.
10. Every one of the Trustees shall be a life Trustee each one of the Trustees shall subject to clause-27 detailed hereinafter hold office as a trustee during this lifetime and shall be entitled to attend all the meetings of the board of Trustees and participate in them.
11. If any of the members of the Board of Trustees be unable to attend the meetings of the Board of Trustees on any amount whatever it shall be competent to the Board of Trustees to pass any resolution or take any decision in his/her absence and carry it out.
12. The Board Trustees shall be entitled to function notwithstanding the death, resignation, disclaimer of the office of any trustees, in eligibility (Physical or mental) of a from functioning and no resolution or decision of the Board of Trustees shall be invalid on the ground of there being a vacancy at any time.
13. The Board of Trustees shall meet at least once in a year at the Central Office or at any of the place chosen by President. At the meeting of the Trustees the decision of the majority shall prevail. The President shall always have a casting vote in case of equity of votes. The Quorum for such meetings except in case of meeting called as per Para 22, detailed below shall be 50% of the total number of existing Trustees as on the date of notice of meeting.
14. All the office bearers shall hold office for a period of five years from the date of election and shall be eligible for re-election. Till the newly elected office bearers enter office and take charge, the bearers shall continue.
15. The Trustees shall cause true and correct account to be kept of the sum of money received and expended on behalf of the Trust. Once every year, the account of the trust shall examine and correctness of the accounts and Balance sheet ascertained by chartered accountant appointed by the Trustees and countersigned by the trustees. The financial year shall be the accounting year of the Trust.
16. Each one of the Trustees shall be entitled to nominate, a successor to his/her office who shall on the death of the trustee who nominated him/her shall become a trustee, in place the deceased Trustee as provided hereunder. In case a nominee being Male/Female legal heir or spouse of the Trustee. Such nominee shall automatically become the Trustee. In case of the nominee being any person other than male legal heir or spouse then the nominee shall become the Trustee only if 2/3rd of the then existing Trustee agree to such a nominee becoming a trustee in the nominee, being not accepted as Trustee as above. The existing should have power to co-opt any other person (preferably an-heir or blood relation of the Trustee) as Trustee of the Trust. On the death of a Trustee without nominative.

17. The Trustee shall have power from time to time to make and after such rules and after such rules and regulations with regard to the conduct of the business and all matters in respect of duty hereby vested to them, as they may think proper. The Board Trustee, if they so choose and for the benefit of the trust, may delegate by means of a resolution in writing any or all of power to any one or more of them or any other person or persons for such time and for such purpose as they deem fit.

19. The Trustees are wholly indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the trust and such expenses. Losses and payment shall be borne by the trust none of the trustee shall in any way be personally liable or responsible for the same.
20. The Trustee shall be respectively chargeable only for such money or securities as they shall respectively actually receive notwithstanding their respective signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts receipts neglects or defaults and not those of each other not for any bankers, auctioneer or other persons with whom or in to whose hands any trust moneys or securities may be deposited or come or for insufficiency in title or difference in value of investment nor for any other loss, unless the same shall happen through their own wilful, default respectively.
21. The Trustee may reimburse themselves and/or discharge out of the said trust properties all expenses incurred in or for the execution of the trust and powers of the presents.
22. Any one Trustee, may in writing, requisition the President to convene a meeting of the Board of Trustees clearly disclosing the matter to be discussed by the trustees and there upon the President shall convene the meeting of the Board of Trustee after giving seven days notice of such meeting to the trustee. In the case the President fails to respond to the requisition of trustee, the said trustee themselves may convene a meeting of the Trustee giving notice of the time of the meeting to all trustee and the decision arrived at such meetings of the Board of Trustee duly convened provided that at least 60% of the total number of trustee attend such meeting and the decision is supported by a 90% majority of the Trustee present.
23. The Secretary shall at all the time be competent to call meeting of the Board of Trustee, suo-motto.
24. The office of the Trustee will be honorary and the trustees shall not be entitled to draw any remuneration for carrying out their duties trust.



25. Any Trustee may resign his/her office by a letter addressed to the secretary under his/ her hands. The resignation shall take effect from the time; the Secretary receives the letter, of resignation. If a Trustee has made a nomination, before resignation, such nominee being a male legal heirs/ spouse or a very close blood relation like brother, shall become a member of the Board of Trust. If there be no such nomination, the Board of Trustee shall appoint any other person (Preferably from out of the male legal heirs/or spouse) as Trustee in place of the person so resigning.
26. A Trustee shall cause to be a trustee of the Board to Trustee if
- He acts against the object of Trust or hinders or hampers the progress of the Lawful and Legitimate activities of the Trust.
 - If he becomes insane or subject to such physical or mental disability as to be incapable of taking part in the activities of the Trust.
 - If he/she is convicted by any court or offence which involves moral turpitude.
 - If he/she does not attended six consecutive meeting of the Board of Trustees With out obtaining the prior permission to absent himself from the Board of Trustees. However
27. With a view to carrying out the objects of the Trust hereto fore mentioned for augmenting its fund, administering the Trust and in the discharge of their duties the trustees shall have the following among other powers:
- To Start, run or support school, college training center for providing clinical, vocational and other types of training center for providing cause of education and to take other steps calculated to further the cause education.
 - To Start, run and support hospitals and medical dispensaries, workshops, research centers and to take other steps calculates to further the cause of education in the institutions.
 - To give scholarships, Medals, Awards, Prizes etc., to the students of all castes and creeds. To make donations or contributions for the objects of the Trust.
 - To apply state and central government Projects, to receive grants from state and central government.
To apply for foreign funds and receive foreign funds.
 - To receive any money or further assets in an shape or from as and when given by the authors of the Trust or any other person or persons.

 - To invest to trust funds from time to time in such business or securities and in such manner as they deem fit, to alter or very the investments from time to time and to realize the investments.




 - i. To executes or negotiate all the necessary papers and documents (whether negotiable on non-negotiable) to receive money's and other assets and to grant receipts and discharge therefore.
 - j. To represent the Trust in all courts (original or appellate) or before any authorities and departments of Government, Semi-Government or local authority.
 - k. To sign and verify all pleading, memoranda or appeal petitions and application of all kings: to compromise, abandon or refer to arbitration whole or any part of the claims by or against the trust: to engage lawyers/pleaders/advocates and take necessary steps.
 - l. To borrow for the purpose of the Trust on the personal credit of the trustees with or without charge and responsibility upon the assets of the trust.
 - m. To meet all the necessary expenses incurred or to be incurred in connection with the creation and execution of this Trust.
 - n. The Trustees shall also have the power to frame such rules and regulations for forming/administering the Governing bodies for the educational institutions to by the Trust.
 - o. The benefits of the Trust shall be open to all irrespective of caste, creed and religion, the funds and the income of the Trust shall be solely utilized towards the achievement of the object and no portion of it shall be utilized for payment to Trustees/Members by way of profit, interest, dividend etc.
28. No amendments to the Trust Deed shall be made which may prove to be repugnant to the Provisions of Sections 2(15), 11, 12 and 13 and 80G of the Income Tax act, 1961. Further no amendment shall be carried out without prior approval of the Commissioner Income Tax.
29. The funds of the Trust/Institutions/Society shall be invested in the modes specified under the Provisions of the Sections 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961.
